

LUTRON HOMEWORKS INTERACTIVE™ SOFTWARE END USER LICENSE AGREEMENT

This Software End User License Agreement (“License Agreement”) is a legal agreement between you and Lutron Electronics Company, Inc. (“Lutron”) for the Lutron software supplied with the HomeWorks Interactive™ lighting control system, which includes computer software and may include associated media, print materials, and on-line or electronic documentation (“Software”). **YOU AGREE TO BE BOUND BY THE TERMS OF THIS LICENSE AGREEMENT BY INSTALLING, COPYING, OR OTHERWISE USING THE SOFTWARE.**

SOFTWARE LICENSE

The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. Lutron and its suppliers retain title to and ownership of the Software, and all intellectual property rights therein. All rights not expressly granted are reserved. The Software is licensed, and not sold.

GRANT OF LICENSE

You are licensed to use the software on the following terms and conditions:

1. You may use the software only on a single computer connected to a HomeWorks Interactive™ system, or a system expressly approved and authorized by Lutron in writing.
2. You may transfer your right to use the software, along with the server on which it is installed, one time only to another party, provided that the other party expressly agrees to the terms and conditions of this Agreement, upon which transfer your license is terminated. You may not rent or lease the software to others, or otherwise transfer or assign the right to use the software, except as stated in this paragraph.
3. You may not decompile, disassemble, reverse engineer, or in any way modify the software without the prior written consent of Lutron, except and only to the extent that such activity is expressly permitted by applicable law, notwithstanding this provision.

LIMITED WARRANTY

This software and documentation are licensed “as is” without any warranty as to their performance, merchantability or fitness for any particular purpose. The licensee assumes the entire risk as to the quality and performance of the software. Lutron warrants that the media on which the Program is furnished will be free from any defects in materials. Exclusive remedy in the event of a defect is expressly limited to the replacement of media. In no event shall Lutron or anyone else who has been involved in the creation, development, production, or delivery of this software be liable for any direct, incidental, special or consequential damages, such as, but not limited to, loss of anticipated profits, benefits, use, or data resulting from the use of this software, or arising out of any breach of warranty, or for any damages whatsoever of any type arising from or related to programming of the HomeWorks Interactive™ system by personnel not trained by Lutron, or for any damages whatsoever of any type resulting from or related to programming of the HomeWorks Interactive™ lighting control system not in accordance with Lutron instructions or national and local safety and electrical codes.

In no event shall Lutron's liability exceed the purchase price of the HomeWorks Interactive™ lighting control system.

APPLICABLE LAW

This Software License Agreement is governed by the laws of the Commonwealth of Pennsylvania. You agree to consent to the non-exclusive jurisdiction of the courts in Pennsylvania.

ENTIRE AGREEMENT

This License Agreement, including any addendum or amendment to the License Agreement which is included with the Software, are the entire agreement between you and Lutron relating to the Software and the support services (if any), and they supersede all prior or contemporaneous oral or written communications, proposals and representations with respect to the Software or any other subject matter covered by this License Agreement. To the extent the terms of any Lutron policies or programs for support services conflict with the terms of this License Agreement, the terms of this License Agreement shall control. The terms of this License Agreement shall not be modified except by the consent of Lutron given in a writing signed by an officer of Lutron.

SEVERABILITY

If any of the provisions of this License Agreement are invalid under any applicable statute or rule of law, then those provisions or portions thereof are to that extent deemed to be omitted.

TERMINATION

Without prejudice to any other rights, Lutron may cancel this License Agreement if you do not abide by the terms and conditions of this License Agreement, in which case you must either destroy or return, at Lutron's sole option, all copies of the Software and all of its component parts.
